CHANGE OF COMPANY NAME AND STOCK SHORT NAME

References are made to (i) the announcement of Hands Form Holdings Limited (the “**Company**”) dated 8 October 2024; (ii) the circular of the Company dated 17 October 2024 (the “**Circular**”), in relation to, among other things, the Proposed Change of Company Name; and (iii) the announcement of the Company dated 5 November 2024, in relation to the poll results of the extraordinary general meeting held on 5 November 2024 (the “**EGM**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Circular.

CHANGE OF COMPANY NAME

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that subsequent to the approval of the special resolution at the EGM, approving the English name of the Company to be changed from “Hands Form Holdings Limited” to “China Wacan Group Company Limited” and the Chinese name of the Company from “恆新豐控股有限公司” to “中國網成集團有限公司” (the “**Change of Company Name**”), by the shareholders of the Company (the “**Shareholders**”), the Certificate of Incorporate on Change of Name was issued by the Registrar of Companies of the Cayman Islands on 7 November 2024.

The Registrar of Companies in Hong Kong issued the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company on 29 November 2024, confirming the registration of the Company’s new English and Chinese names in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

With effect from 9:00 am on 13 December 2024, the stock short name will be changed from “HANDS FORM HLDG” to “CHINA WACAN” in English and from “恆新豐控股” to “中國網成” in Chinese for the purpose of trading in the shares of the Company (the “**Shares**”) on the Stock Exchange. The stock code of the Company on the Stock Exchange will remain unchanged as “1920”.

EFFECT OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company will continue to be evidence of valid title and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the exchange of the existing share certificates for new share certificates bearing the new name of the Company. Thereafter, the new share certificates of the Company will be issued under the new name of the Company.

The Change of Company Name will also not affect the daily business operations and financial position of the Group.
